<u>Terms and Conditions Applicable to All Applicants</u> <u>Evan Thomas Memorial Scholarship</u>

Eligibility of Candidates:

- 1. Candidates shall be a graduating Grade 12 student from any high school within the Saskatoon Public School system or the Greater Saskatoon Catholic School system who intend to pursue post-secondary studies.
- 2. Candidates shall demonstrate team leadership.
- 3. Candidates shall demonstrate athletic qualities in a team sport.
- 4. Candidates shall demonstrate academic proficiency.
- 5. While the selection committee shall use the above criteria to determine who is eligible for the award, the decision is at the discretion of the selection committee.

Terms and Conditions on All Applicants:

- 1. The applicant must be a graduating Grade 12 student from any high school in the Saskatoon Public School system or the Greater Saskatoon Catholic School system who intends to pursue post-secondary studies.
- 2. All applicants agree that the selection of the successful applicant to whom the Evan Thomas Memorial Scholarship (the "Scholarship") is awarded is the sole and final decision of the Evan Thomas Memorial Scholarship Committee (the "Committee") and cannot be reviewed or appealed.
- 3. All applicants agree that the Committee may contact all coaches listed in the application, any educators at their current and past secondary educational facilities, and references and teammates provided in their application to verify the statements made by the applicant or in the applicant's scholarship application, further investigate their roles and leadership in team environments and to verify their enrolment and academic status.
- 4. During such interactions, personal information about the applicant may be discussed. The Committee will endeavour to use their best efforts to ensure that such personal information remains confidential, but will not be responsible for any personal information that becomes public knowledge as a result of disclosures made by individuals interviewed by the Committee as the result of evaluating the applicant's application.

Terms and Conditions Applicable to the Scholarship Award Winner:

If the Applicant is selected as the winner of the Scholarship, as the Recipient of the award, the student agrees that:

- 1. The Recipient will submit a satisfactory picture of themselves along with an explanation of the impact winning this scholarship has had on them, which will be published on the scholarship's website for a period of not less than one year within six months of the awarding of the scholarship.
- 2. The Recipient will allow their name, name of the secondary school from which they graduated, and the name of the post-secondary school which they subsequently attend to be published on the scholarship website in perpetuity.
- 3. The Recipient will forfeit the award should they be unable to provide a written confirmation of enrolment from the post-secondary institution they plan to attend by December 15th in the year of the award. The award shall then be awarded to the runner-up.
- 4. Prior to receiving the award, the recipient shall present to the Committee and the Saskatoon Community Foundation verification of registration in any one of the following types of schools:
 - i. An accredited university of college; or
 - ii. A publicly funded vocational and/or technical institution.
- 5. The award shall be paid by on behalf of the Committee by the Saskatoon Community Foundation directly to the Recipient's account at a registered, notfor-profit educational institution considered a "qualified donee" by Revenue Canada Agency.
- 6. The Recipient agrees that the family of Evan Thomas or a person chosen by the Committee will present the award to the Recipient.
